This document regulates the amount of remuneration for the Licensors (Sole proprietor Manukyan Sirvard Armenakovna, Armenia, and Sole proprietor Evera Pelle Dmitry Cheglik, Poland) for granting the right to use a simple non-exclusive license of the computer program "Accounting system for small businesses Upp" (hereinafter referred to as the Program or Upp) in accordance with the License Agreement posted in the public domain on the Internet at <https://app.upp.app/agreement.pdf>.

1. License name: "Paid license"
2. Starting balance of the Personal account: \$5 (allows to use Upp for free up to 10 days)
3. Fixed subscription fee: \$0.49 per day
4. Program features included in the fixed subscription fee (terminology according to the License Agreement):
 - a. 1 (one) Business
 - b. 2 (two) Wallets
 - c. 2 (two) Lists
 - d. 1 (one) Schedule
 - e. 1 (one) Company
 - f. 3 (three) Employees
5. Fee for additional features:
 - a. 1 (one) additional Business: \$0.09 per day
 - b. 1 (one) additional Wallet: \$0.03 per day
but not more than \$1.5 per day for all additional wallets
 - c. 1 (one) additional List: \$0.03 per day
 - d. 1 (one) additional Schedule: \$0.03 per day
 - e. 1 (one) additional Company: \$0.09 per day
 - f. 1 (one) additional Employee: \$0.09 per day
 - g. 1 (one) gigabyte for storing files: \$0.09 per day
rounding up to the nearest whole number of gigabytes
 - h. Sending 1 (one) WhatsApp message via Green API (<https://green-api.com/en/>): \$0.01
 - i. Sending 1 (one) SMS message (up to 70 characters) via Upp SMS gateway: \$0.05
 - j. Premium turnkey setup and business analyst assistance: \$49 (or free on Upp personal account balance top-up to more than \$150 at a time)

Amounts given in US dollars and include applicable taxes. Payment is made from the balance of the Licensee's Personal account. The balance can be replenished via PayPal (<https://paypal.com>) by requesting through the Personal Account.

Bonuses when replenishing your Personal Account balance:

1. **10%** when replenishing more than \$50
2. **20%** when replenishing more than \$150
3. **30%** when replenishing more than \$300 (for example, payment of \$300 increases the Personal Account balance by \$390)
